WEBSITE USERS' CONSENT TO PERSONAL DATA PROCESSING

The private individual (hereinafter the "User") sends his/her personal data specified by him/her in the web-form at website <http://podarokangelu.com> (hereinafter the "Website") and thereby grants his/her consent to the Gift to an Angel Charitable Foundation (address: 36, build. 1 Lyusinovskaya Str., 115093, Moscow, Russia) to personal data processing to the extent stipulated in this document.

By granting his/her Consent, the User represents that:

- he is acting voluntarily, by his/her own free will and in his/her own interest;
 - he/she is legally capable;
 - the consent is specific, informed and explicit.
1. This Consent is given to personal data processing with use of automated means or without such means.
 2. This Consent is given to processing of the following personal data:
 - general personal data provided by the User to his/her discretion: e-mail address, contact phone number;
 - data on technical facilities (devices): IP address, operation system, type of browser, geographic location, Internet provider; data on the Website using (inter alia information on visited pages); information automatically collected when accessing the Website, i. a. with use of cookies; information collected in consequence of the User's actions including the following: information on submitted requests, feedbacks and questions.
 3. Personal data are not public available.
 4. The Foundation executes the processes associated with personal data processing with a view to fulfilment of the obligations in accordance with the Public Offer of Voluntary Donation (http://podarokangelu.com/uploads/files/public_offer_of_voluntary_donation.pdf) and the Service Offer of Automatic (Recurrent) Payment (http://podarokangelu.com/uploads/files/service_offer_automatic_payment.pdf).

Such obligations of the Foundation include:

- sending of messages, notices, requests, informational mails, including the information on funds collected in favour of the Foundation wards, to the e-mail address provided by the User;
 - provision of consultancy and technical support to the User. The Foundation has the right to use the phone number and/or e-mail address provided by the User for communication with the User;
 - if necessary, conducting of any kinds of studies, inter alia analysis for the Service quality improvement;
 - ensuring serviceability and security of the Website.
5. The basis for the personal data processing: clause 24 of the Constitution of the Russian Federation; clause 6 of Federal Law No. 152-Φ3 “On Personal Data”; public offers of the Foundation; Privacy Policy; Consent.
 6. When being processed, personal data will undergo the following: collection, recording, ordering, accumulation, storage, adjustment (updating, modifying), electronic copying, retrieval, use, de-personalisation, blocking, removal, destruction.
 7. The processed personal data are to be destructed or de-personalised: within 30 (thirty) days after withdrawal of the consent to personal data processing by the User.
 8. The Consent may be withdrawn by the personal data subject or his/her representative by filing a written application to the Foundation to its address (refer to the Consent recitals).
 9. This Consent is effective all along until the moment of personal data processing termination as specified in clauses 8 and 9 of this Consent.
